Up to 1 oz bud/leaf (instead of 8)

Delivery (homemade, for no consideration, to those 21 and over)

Up to 1 oz, 16 oz solids, 16 oz concentrates, and 72 oz liquids

Exemption from Unlawful Possession, Delivery or Manufacture (475B.907-475B.919; 475B.943)

Cardholder and caregiver may jointly have

6 mature marijuana plants ORS 475B.831(1) 24 ounces ORS 475B.834(1)

Designated grower

6 mature plants for up to 4 cardholders ORS 475B.831(2)
12 pounds per outdoor plant allowance ORS 475B.834(3)(a)
6 pounds per indoor plant allowance ORS 475B.834(3)(b)
